

We continue to work with Council members and decision makers to identify the highest priority information needs of the State and opportunities for CCST.








MAKERSPACE

Response has been enthusiastic. CCCO has increased investment in the program significantly, up to \$17 million.




CALIFORNIA PLANS

Team from GoBiz working on California's Sustainable Freight Action Plan reached out to CCST for input on select issues:

- Defining & measuring competitiveness
- New technology
- Workforce development

CCST has held discussions with GoBIZ, the Air Resources Board, and CalTrans, specifically Issue 6 in Appendix C for possible CCST involvement

"Convene stakeholders to identify and deploy strategies that consider commercial viability and promote the competitiveness of California's statewide and local freight transportation system, develop tools and share data to analyze benefits and impacts of actions including costs, and develop and implement a quantitative metric to track progress."




GRAND CES CHALLENGES

AB 2452 (Assembly Member Bill Quirk)
Would allow California agencies to sole
source contracts to CCST.

Bill is on hold until a consensus can be reached between CCST, the Dept. of General Services, and the legislative analysts.
